#### SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. For your information, the minimum 20% reservation for each LEA may be found HERE.

Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. Deposit CSD began the collaboration with a community-wide survey that was made available to all staff, parents, students and community members and organizations. Following the survey, a committee meeting of stakeholders was convened on 7/27/21 to review the allocation, survey results, allowable uses, and restrictions.

The committee worked to identify priorities and create a base spending plan which was finalized by Deposit CSD admin.

The results of the survey and the proposed spending plan created by the committee can be found on the website identified in #2.

Throughout the course of the grant funding, the committee will be reconvened to review spending (to date), evaluate the progress, and make suggestions for amendments as needed.

Deposit CSD uses a variety of assessment tools to monitor student progress both formatively and summatively. On-line resources such as DIBELS, Literably (F & P) and and eDoctrina are just a few that we have used in the past. Teams functioning under the PLC model will meet weekly to review standards and identify which students need reteaching/intervention to meet the prioritized standards. Weekly data will be collected and analyzed based on common assessments.

Interventions and supports may include but not be limited to: reteaching in small groups with classroom teacher or intervention specialist, alternative methods of instructional delivery depending on the skill, finding alternative curricular materials, student sharing and pull-out, intensive intervention when warranted.

5. In the space provided below, please describe how the LEA will use the funds it reserves under section 2001(e)(1) - the required reserve of 20% of funds - to address the academic impact of lost instructional time through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year.

Deposit CSD will be apportioning the majority of its annual ARPA spending on activities designed to address learning loss. These activities include expanded summer learning opportunities, as well as after school enrichment opportunities for students at all grade levels. Additionally, the district plans to hire instructional support personnel that can assist in classrooms with small group, targeted interventions designed by teaching staff. Following the pandemic, student need for interventions throughout the day (as well as in addition to the school day) is evident from a variety of sources, but most recently noted in the student scores from the grades 3-8 ELA and Math exams.

Following interventions, the goal for 2021-2022 would be to see an increase in student scores (proficiency) of 10 percent. For the purposes of this grant, DCS will use the benchmarks of grade 4 and grade 8 to monitor progress.

The remaining funds will be used to support the development of college/career readiness programs such as CTE offerings, job shadowing/coaching and software to support these programs. Some monies will be used to contract with license therapists/social workers who can provide mental health support to students and families. Additionally, the District will use the monies to meet the following needs:

- 1) Hire a 10 month Academic Enrichment Coordinator: The administrative position will be responsible for tracking the data and funding, and ensuring that programs are aligned to student needs.
- 2) Engage in teacher development regarding the PLC philosophy and structure. Solution Tree will be used for the purpose of providing this on-going professional development.
- 3) Purchase an outdoor pavilion that can be used as an outdoor learning space for students in grades pk-12.

The district does not currently have 4 subgroups of students. The district has two subgroups: economically disadvantaged students and students with disabilities.

Because the district experiences a poverty rate of 65-70%, the majority of our students in poverty will be directly affected by the programs implemented. Likewise, our SWD population will have full access to all programs made available by the grant both during the school day and after the school day (and summer). Our students with disabilities are included in the general education setting to the maximum extent possible based on their disability and are able to access all services that the district has to offer.

In order to assist our subpopulations in their access to the programs, the district will provide transportation to and from the programs. Additionally, the district will provide appropriate accommodations and modifications while students are in attendance of any district program.

Using Survey Monkey, the district will create and distribute a survey via mass emails (SchoolMessenger) to staff, students and parents. The district will also make the survey available on the website and Facebook. Once information is collected, the Federal Funding committee will convene to review the results. This process will occur at least one time/year at the end of the normal fiscal year (June 30).
